## Lifetime Limited Warranty

### TERMS AND CONDITIONS

COVERAGE: The Allmet Roofing Products *Signature Series* Lifetime Limited Warranty (this "Limited Warranty") extends only to a purchaser of the Allmet **Continental**, **Shadowline** and **Wood Shake** panels and trims ("Allmet Product") who has been issued a Limited Warranty Certificate and paid for the Allmet Product in full (the "Purchaser"), and to subsequent owners of the property to which the Allmet Product is originally affixed after purchase (the "Property"). Subject to the terms and conditions herein, Allmet Roofing Products hereby warrants that for the lifetime of Purchaser during Purchaser's ownership of the Property or, if the Property is transferred by Purchaser, for fifty (50) years from the date of installation of the Allmet Products, that Allmet Products will be free from manufacturing defects in workmanship and materials such that:

- Each Allmet Product will withstand winds of up to 120 miles per hour;
- Steel substrate on Allmet Products will not burn, and will not be penetrated by hailstones less than two and one-half inches (2.5") in diameter such that the Allmet Products are no longer weatherproof; and
- The appearance of the surface coating of Allmet Products will not materially deteriorate beyond normal weathering and aging.

EXCLUSIVE REMEDY: In the event any Allmet Product fails to meet the above standards, Allmet Roofing Products will, at its sole option, provide repairs to the Allmet Product, or will provide replacement products. You may be required to pay installation, freight or shipping costs for replacement products provided by Allmet Roofing Products, at its sole discretion. You agree to pay Allmet Roofing Products' reasonable costs and expenses incurred in performing any physical inspection of Allmet Products that are subject to a warranty claim, including a deposit of \$500.00 at Allmet Roofing Products' request prior to such inspection. Any repair or replacement by Allmet Roofing Products shall not extend the term of this warranty except as required by law or as agreed in writing by Allmet Roofing Products. This is the sole and exclusive remedy under this Limited Warranty, and in no event shall Allmet Roofing Products have any liability for any consequential, incidental, economic, indirect, special or punitive damages or losses of any kind whatsoever. (Advisory: some states do not allow the exclusion or limitation of incidental or consequential damages).

REGISTRATION AND TRANSFER: After it has been registered by Purchaser, this Limited Warranty automatically transfers to a subsequent owner of the Property, and you do not have to notify or contact us in order to transfer this warranty protection. This is a valuable provision of your Limited Warranty and enhances the value of your Property. We encourage you to keep this Limited Warranty with your permanent records in a safe place.

NO OTHER WARRANTIES: This Lifetime Limited Warranty is the only warranty given by Allmet Roofing Products and no other warranties of any kind have been made with respect to the Allmet Products. (Advisory: some laws do not allow limitations on certain implied warranties). This warranty gives you specific legal rights, and you may have other rights which vary from state to state.

CLAIMS PROCEDURE: If you experience a problem with an Allmet Product that you believe is covered by this Limited Warranty, please contact us at via phone at (800) 265-9357, or via e-mail to [info@allmet.com](mailto:info@allmet.com) and provide us with your name, address, telephone number, the certificate number of this warranty, and a specific and detailed description of the defect or problem, as well as any other information or materials you believe is relevant. You may be required to provide additional information or materials at the request of Allmet Roofing Products, including photographs. You must notify us of any problem or defect within thirty (30) days after you discover or reasonably should have discovered such problem or defect.

#### OTHER TERMS, CONDITIONS, DISCLOSURES AND LIMITATIONS:

1. While we expressly warrant that the Allmet Products are free from manufacturing defects as set forth above, the performance of your Allmet Product is largely dependent on the manner in which it is installed and cared for. Consequently, this Limited Warranty shall not apply to:
  - Allmet Products that are not installed by an Allmet factory trained installer or contractor;
  - Allmet Products that have been damaged, modified, altered or changed in design or function after shipping from Allmet Roofing Products' facility, or used or installed for a purpose other than roofing.
  - Damage caused by improper installation, or the failure of the installer to follow Allmet Roofing Products' installation standards and instructions, or to follow reasonable professional installation procedures;
  - Damage caused by foot traffic or foreign objects, the application of cleaning fluids, coatings or chemicals not specifically approved and authorized by Allmet, or the failure or movement of the structure of the Property on which the Allmet Products are installed.

We recommend that you ask your installer or contractor about warranties covering their installation services.

2. Dealers, distributors and installers of Allmet Roofing Products are independent contractors are not authorized to extend other warranties on behalf of Allmet Roofing Products, or to modify the terms of this Limited Warranty in any manner.
3. This Limited Warranty shall be void in the event of repairs or modifications made by any person to the Allmet Products that are not first approved in writing by Allmet Roofing Products, except temporary emergency repairs.

If any provision of these Terms and Conditions is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions shall nevertheless continue in full force and effect. Please keep a copy of these Terms and Conditions for your records, along with your Warranty Certificate and/or Confirmation of Change, record of payment and installation and Warranty Request Card.
